Please amend your records to reflect the changes shown on the attached sketch.

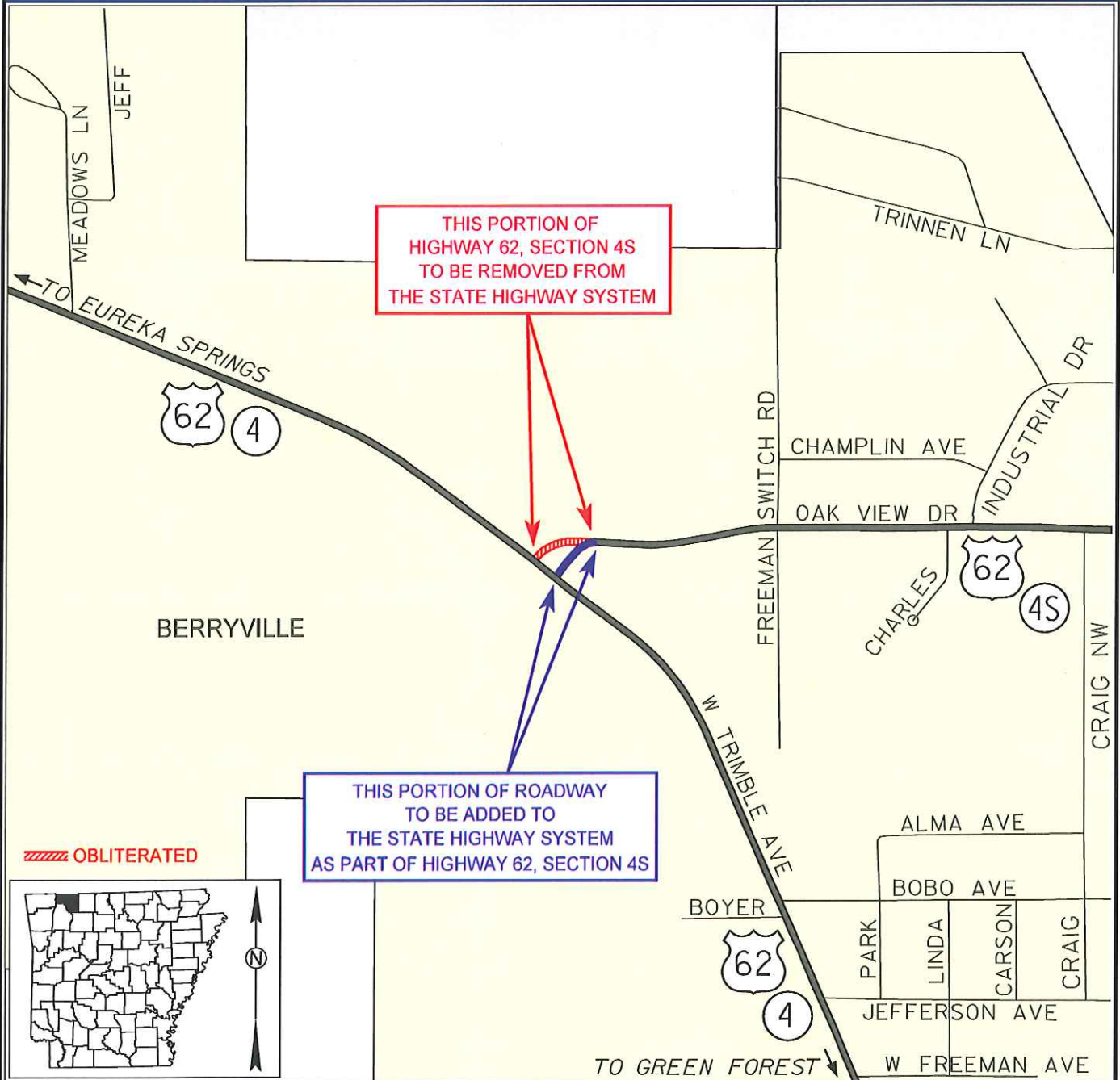
